Overview

This report is published pursuant to state Executive Law §838-a, which requires statistical reporting and testing related to sexual offense evidence kits.

The law designates the state Division of Criminal Justice Services (DCJS) as the agency responsible for informing law enforcement agencies and forensic laboratories about their reporting requirements and collecting statistical data reported quarterly by those agencies and laboratories. It also requires DCJS to submit to the leadership of the New York State Senate and Assembly an annual report detailing statistics as submitted to DCJS by those agencies and laboratories.

This report contains information about kits received by law enforcement agencies and laboratories for the 2019 calendar year, broken down by quarter, as reported by those agencies.

Police departments, sheriffs' offices and district attorneys' offices are required to report:

- the number of sexual offense evidence kits received during each quarter;
- the number of kits received each quarter that were submitted to a forensic laboratory;
- the number of kits received each quarter that were submitted to a forensic laboratory within 10 days;
- the number of kits received each quarter that were submitted to a forensic laboratory more than 10 days later; and
- the total number of kits that remained in inventory at the end of each quarter.

Forensic Laboratories are required to report:

- the number of sexual offense assault kits received during each quarter;
- the number of kits received each quarter that were processed;
- the number of kits received each quarter that were not tested; and
- a reason why untested kits were ineligible for testing.

Table 1: Law Enforcement and Prosecutorial Agencies

Summary:

- 543 (90%) of 601 agencies provided data for this report.
- 3,055 kits were received by those agencies during 2019.
- 36 kits remained in their custody and control on Dec. 31, 2019.

Table 2: Forensic Laboratories

Summary:

- All nine forensic laboratories in the state provided data for this report.
- 3,326 sexual offense evidence kits were sent to those labs in 2019.
- 3,538 kits were processed as of Dec. 31, 2019. This includes kits received prior to the reporting period.
- 966 kits were in progress at those labs as of December 31, 2019.

Note:

- Tables 1 and 2 list all police departments, sheriffs' offices, district attorneys' offices and forensic laboratories required to report information to DCJS and the corresponding data they reported to DCJS.
- Entities that did not report for a particular quarter are denoted with an asterisk.
- Information contained in this report was received by DCJS as of March 9, 2020.
