SUBJECT: NYS IBR Edit #762 UPDATE

---

In August 2022, the New York State Crime Reporting Unit fixed a defect in the state's programming of NYSIBR Edit #762. The modified programming now reflects the literal explanation of Edit #762, which requires certain IBR offense codes to be linked to the Victim Type of Society/Public. Due to this change, many agencies are experiencing an increase in the number of 762 errors appearing on their monthly transaction reports.

If your Records Management System (RMS) does not identify Error 762 as coded by the state, please share this memorandum with your RMS vendor and request they update Edit #762. Spectrum Justice Services (SJS) users will soon be update SJS to ensure that the IBR Review identifies these 762 errors.

### **Edit #762 Error Message and Explanation**

762 When INCIDENT/COMPLAINT OFFENSE is a Crime Against Society it must be linked to a Society/Public VICTIM TYPE

If INCIDENT/COMPLAINT OFFENSE is 35A, 35B, 39A, 39B, 39C, 39D, 40A, 40B, 40C, 370, 520, 720, 90B, 90C, 90D, 90F, 90G, 90J, 90Z or 999, it must ONLY be linked to a Society/Public VICTIM TYPE

### **Common scenarios that trigger Edit #762 and how to correct them**

The Crime Reporting Unit has identified the most common triggers to Edit 762 and solutions to address the issues. If you have a 762 error that is not resolved by one of these solutions, please contact the Crime Reporting Unit at [infonysibr@dcjs.ny.gov](mailto:infonysibr@dcjs.ny.gov).

1. Agencies are using *G (Government)* as the Victim Type for offenses classified as 90Z or 999. This can be corrected by changing the Victim Type to *S (Society/Public)*. Please note SJS Users can ignore the resulting edit 684 if they have not yet updated their SJS.
2. Agencies are using Criminal Contempt 2<sup>nd</sup> Disobey Mandate (PL 215.50 subsection 03) and trying to report a person victim. PL 215.50 sub 03 requires a Society/Public Victim Type.

3. Agencies are reporting a law that can be classified under more than one IBR offense classification. Endangering the Welfare of a Child - Act in a Manner Injurious to a Child less than 17 (PL 260.10 subsection 01) can be classified as multiple IBR offenses and may require reporting a supplemental Crime Against Person charge if the endangerment requires reporting a person victim.
