Hate Crime in New York State 2017 Annual Report

Hate crime incidents reported to law enforcement in New York State decreased 6.7 percent in 2017, however, the number of reported anti-black incidents increased significantly: up 36 percent when compared to 2016. This decline comes one year after the state experienced an 18.8 percent spike in reported incidents in 2016, which reversed a three-year decline in these crimes statewide.

Hate crimes target individuals, groups of individuals or property because of a perception or belief about race, ethnicity, gender, sexual orientation, religion or other characteristic defined under law.

While these crimes represent only a fraction of the overall reported crime in the state, they impact more than their specific target and can have a detrimental and disproportionate effect on the safety of all New Yorkers. Given the troubling spike in 2016 and to remain vigilant against future increases, New York State continues its efforts to prevent and respond to hate crime, as well as other forms of discriminatory behavior and bias through its [Hate Crimes Task Force](#), led by the New York State Police with assistance from the Division of Criminal Justice Services (DCJS) and Division of Human Rights.

DCJS is statutorily required to annually publish a report analyzing hate crime incidents. This report contains hate crime incidents for 2017 reported to the agency by police departments and sheriffs' offices through the Uniform Crime Reporting (UCR) system as of May 14, 2018. It also details hate crime arrests reported by those agencies and dispositions provided by the courts; those data sets are derived from the Computerized Criminal History (CCH) system at DCJS. This report details:

- Hate crime incidents by offense, bias motivation and demographic characteristics, such as age and gender of known offenders.
- Arrests made in 2017 for one or more offenses charged as a hate crime.

- Hate crime arrests that resulted in a criminal conviction or youthful offender adjudication for the five-year period from Jan. 1, 2013, through Dec. 31, 2017.
- Hate crime incidents reported annually from 2013 through 2017. These trends are detailed in the appendices to this report.

Major Findings

- ◆ More than half (57.9%) of the 558 reported hate crimes targeted property and 42.1 percent targeted people.
- ◆ Hate crimes against property (323) increased slightly, 1.6 percent, while crimes against individuals (235) decreased 16 percent.
- ◆ Consistent with prior years, the most frequently reported bias motivations for hate crimes against property were anti-Jewish (63.8%) and anti-black (15.2%).
- ◆ The most frequently reported bias motivations for hate crimes against individuals were anti-black (22.6%), anti-gay male (20.4%), and anti-Jewish (14%).
- ◆ The number of reported anti-black incidents increased significantly in 2017: up 36 percent when compared to 2016.
- ◆ Most hate crime incidents involved criminal mischief (54.7%) and simple assault (30.6%).
- ◆ The most common hate crime arrest charges were aggravated harassment (42.6%) and assault (22.9%).

Reported Hate Crime Incidents

Under New York’s Hate Crime Law (Penal Law Article 485) a person commits a hate crime when a designated offense is committed targeting a victim because of a perception or belief about their race, color, national origin, ancestry, gender, religion, religious practice, age, disability or sexual orientation, or when such an act is committed as a result of that type of perception or belief. These crimes can target an individual, a group of individuals or public or private property.

Table 1 details hate crime incidents reported by Uniform Crime Reporting (UCR) categories, used by the FBI to allow for uniform reporting across all 50 states.

Appendix 4 details the New York State Penal Law crimes that correspond to the FBI’s UCR categories.

Investigating officers are responsible for identifying an offense as a hate crime and specifying the bias motivation when reporting the incident.

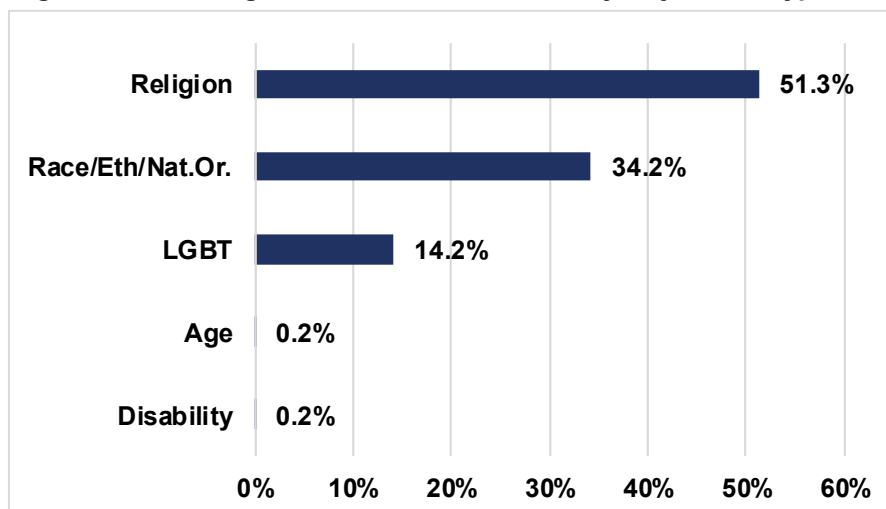
- Of the 558 hate crimes reported, 323 (57.9%) targeted property and 235 (42.1%) targeted individuals.
- Criminal mischief (305) accounted for 54.7 percent of all hate crimes and 94.4 percent of property crimes.
- Simple assault (171) accounted for 30.6 percent of all hate crimes and 72.8 percent of crimes against individuals.

- More than half — 51.3 percent — of all incidents involved an anti-religious bias, with 286 incidents reported.
- Race/ethnicity/national origin was the bias motivation in 191 incidents (34.2%) and LGBT was the bias motivation in 79 incidents (14.2%).
- Five-year trends for all hate crime bias motivation types are detailed in Appendix 1.

Note: Totals in this table may not equal 100 percent due to rounding. In addition, the percentage for each specific bias type under each bias motivation category (i.e. Transgender, Black, Jewish) relates to the total number of all reported hate crimes.

- The most common bias motivation was anti-religion, with 286 hate crimes reported. Anti-Jewish crimes accounted for the overwhelming majority of those incidents: 239. Anti-Jewish crimes also accounted for 42.8 percent of all hate crime incidents.
- Anti-black bias was up 36 percent compared to 2016 and accounted for more than half (102 of 191) of the incidents involving anti-race/ethnicity/national origin bias and 18.3 percent of all reported hate crimes.
- Anti-LGBT bias accounted for 14.2 percent of all reported hate crimes.

Crimes Against Persons

- Bias against race/ethnicity/national origin was the most common bias type in crimes against persons, with 112 incidents (47.7%) reported. This was followed by anti-LGBT, 71 incidents (30.2%), and anti-religion, 51 incidents (21.7%).
- Black individuals were the most commonly targeted (53 of 235), followed by gay male (48) and Jewish (33).
- Within the anti-religion category, anti-Jewish bias (33) and anti-Islamic bias (16) accounted for 49 of the 51 incidents.

Property Crimes

- Of the 323 reported hate crime incidents targeting property, 72.8 percent (235) were motivated by a bias against religion, and 24.5 percent (79) were motivated by a bias against race/ethnicity/national origin.
- Anti-Jewish bias was most commonly reported in incidents targeting property: 63.8 percent (206 of 323 incidents).
- The second most common bias type was anti-black: 15.2 percent (49 of 323 incidents).
- Appendix 1 details five-year trends.

Offenders as Reported by Their Victims

Reporting of offender demographic characteristics by the victim or another party is often incomplete, partly due to the fact that some hate crimes involving property do not involve direct contact between the target and perpetrator.

At least one type of offender demographic — gender, age or race/ethnicity — was reported in 224 incidents. Those incidents involved a total of 290 offenders because a single incident can involve multiple offenders.

Table 3 presents the gender, age and race/ethnicity of offenders in those 224 incidents as reported by a victim or other party.

- The gender of 289 offenders was reported and the vast majority were male: 250 of 289.
- Age was reported for 217 offenders: 165 individuals (76%) were 39 years old or younger, with 69 between the ages of 25 and 39 and 96 younger than 25.

- Race/ethnicity of 269 offenders was reported: 42 percent white, 36.1 percent black and 19.7 percent Hispanic. The race of 7.2 percent of offenders was reported as unknown.

Table 4 presents the number of offenders involved in the 224 hate crime incidents.

- The majority of the 224 incidents (84.4%) involved one offender.
- Two or more offenders were reported in 35 incidents (15.5%), for a total of 101 offenders involved. Of the 35 incidents, 16 involved two offenders, nine involved three offenders, nine involved four offenders and one involved six offenders, which was the most reported for any one incident.
- The most common offenses involving known offenders were simple assault (145 or 50%) and aggravated assault (60 or 20.7%).

Unknown Offenders

- There was no information reported about the number of offenders involved in 334 of the 558 reported hate crimes. Of those 334 incidents, 269 (80.5%) involved crimes against property.
- The majority of incidents with unknown offenders were criminal mischief (264 or 79%) and simple assault (57 or 17.1%).
- Of the incidents with unknown offenders, 60.5 percent (202) were motivated by anti-Jewish bias.

County of Reported Hate Crime Incidents and Arrests

Table 5 details hate crime incidents and arrests by county in 2017.

Hate crime incidents and/or arrests were reported by law enforcement in 53 of the 62 counties in New York State. Law enforcement agencies reported no incidents or arrests in the remaining nine counties; those counties are excluded from the table below.¹

Arrests represent a hate crime charge being brought at the time of the arrest, as reported to DCJS by the arresting agency. The number of reported hate crime incidents and arrests in a given year should not be compared: not all hate crime incidents in a given year result in an arrest; arrests can occur in a different year than the associated crime; and one incident can involve multiple offenders.

- Law enforcement in the five counties that comprise New York City — Bronx, Kings, New York, Queens and Richmond — reported 58 percent of all hate crime incidents in the state and made 54 percent of all hate crime arrests.
- In the Rest of the State, 55 percent of incidents were reported by law enforcement agencies from four counties: Suffolk, Nassau, Westchester and Erie.
- Police departments or sheriffs' offices in eight counties made one or more hate crime arrest, but reported no incidents: Chautauqua, Chemung, Essex, Jefferson, Orleans, St. Lawrence, Washington and Wyoming.

¹ The following nine counties reported no hate crime incidents or arrests in 2017: Allegany, Cortland, Fulton, Montgomery, Ontario, Otsego, Schuyler, Seneca and Yates.

Note: MTA is the Metropolitan Transportation Authority Police Department, which serves multiple counties.

Hate Crime Arrests

New York State Penal Law Article 485 details the offenses designated as hate crimes.

Table 6 shows the most serious Penal Law offense charged as a hate crime for the 244 arrests made in 2017. Of those, 43.4 percent were offenses against public order and 30.7 percent were assault and related offenses.

The most common hate crime arrest charges were second-degree aggravated harassment (83), a misdemeanor; third-degree assault (31), a misdemeanor; second-degree assault (24), a felony; and first-degree aggravated harassment (21), a felony.

This table also groups arrest charges by the corresponding Uniform Crime Reporting (UCR) category. As noted on Page 2, the FBI defines these categories.

Dispositions of Hate Crime Arrests

The processing of cases in criminal court often takes several months to be completed and can result in a range of dispositions.

Dispositions by Crime Type

This section only includes hate crime arrests that resulted in either a criminal conviction or youthful offender adjudication² for the five-year period from 2013 through 2017. The term adjudication is used in cases involving youthful offenders because the case is sealed and details of the case are not permitted to be disclosed, except under limited circumstances defined in state law.

The courts reported 418 convictions and youthful offender adjudications to DCJS between 2013 and 2017.

Table 7 details crime type (felony or misdemeanor) and notes whether the conviction or youthful offender adjudication was for a hate crime or another Penal Law crime.

- There were 249 dispositions that resulted in criminal convictions to misdemeanors, 118 for felonies and 51 youthful offender adjudications.
- Of all dispositions, 126 resulted in convictions or youthful offender adjudications to hate crime offenses. The remaining 292 dispositions were for offenses not designated as hate crimes.
- Of the 292 non-hate crime dispositions, 69 (23.6%) were felony convictions and 188 (64.4%) were misdemeanor convictions.

Disposition Charges

Table 8 shows the most serious charge for the 418 convictions and youthful offender adjudication, as reported for the five-year period from 2013 through 2017. These charges are grouped by UCR category.

- Of all dispositions, 65 percent involved crimes against individuals (272). The majority of these convictions were categorized either as simple assault (201) or aggravated assault (44).
- Property crime offenses were involved in 24.6 percent of dispositions. The most common property crime convictions were criminal mischief (52) and larceny (28).
- Disposition charges by Penal Law are further detailed in Appendix 5.

² Offenders who are age 16 through 18 at the time of their crime may be adjudicated as youthful offenders (see Criminal Procedure Law 720.10). A youthful offender (YO) adjudication broadens sentencing options and seals the criminal record.

Sentences for Convictions and Youthful Offender Adjudications

Table 9 presents the type of sentence imposed by the courts for the 418 convictions and youthful offender adjudications*.

Of those convicted or adjudicated as youthful offenders:

- 147 (35.2%) were sentenced to jail,
- 87 (20.8%) were sentenced to conditional discharge,
- 79 (18.9%) were sentenced to state prison, and
- 61 (14.6%) were sentenced to local probation.

*Youthful offender adjudications are sealed but individuals can serve any of the sentence types noted.

Appendix 3 details hate crime incidents reported from 2013 to 2017 by UCR offense type.

Reported hate crimes decreased by 6.7 percent when comparing 2017 to 2016. A five-year high of 617 incidents was reported in 2013.

Crimes against property increased 1.6 percent and crimes against individuals decreased by 16.1 percent, when comparing 2017 to 2016.

The 235 incidents reported against individuals in 2017 was the lowest during the five-year period. The 323 property crimes reported in 2017 was the highest during this same time frame.
