## **Use of Force Incidents: Data Notes**

Use of Force incidents detailed in <a href="this spreadsheet">this spreadsheet</a> occurred from July 11, 2019, through Oct. 31, 2020. Police agencies reported these incidents to the state Division of Criminal Justice Services (DCJS). The <a href="first Use of Force report">first Use of Force report</a> published by DCJS provides an overview of reported incidents and additional information about the law, data collection systems and definitions of data elements.

## **Additional Notes**

- This spreadsheet only contains agencies that reported use of force incidents.
- Each row in the spreadsheet represents one use of force incident except for seven incidents that are displayed on more than one row because two agencies reported more than 10 officers involved in each of those incidents: New York State Police (response IDs 3771, 3778 and 3951) and Rochester Police Department (response IDs 4679, 4681, 4682 and 4705).
- New York City Police Department (NYPD) only reported incidents where a firearm was
  used or discharged, or where a chemical agent, electronic control weapon, or impact
  weapon was used or deployed. In addition, the NYPD did not report whether a

chokehold or restraint was used or if there was conduct that resulted in serious bodily injury or death.
