Description: The Division of Criminal Justice Services is interested in procuring information

technology services to modify the existing Caseload Explorer, a proprietary automated case management system currently used by 57 probation departments. Services are being solicited for the purpose of providing necessary automation of critical information and data collection/sharing associated with implementation of the recently enacted Raise the Age law. Additionally, services would need to be able to integrate with existing state approved assessment tools, provide comprehensive case planning functions which are based upon identified risk and needs, provide a selected mental health assessment screen and results for the screening of probation clients, track probation client program participation, provide a mechanism for programs to provide information to the probation case management system, provide select probation practice performance measures to probation officers, supervisors, directors, and to DCJS' Office of Probation and Correctional Alternatives and

the Office of Justice, Research and Performance, provide probation client web reporting and two way text communication which will provide a mechanism for text communication between probation staff and their clients, DCJS expects

that additional support including, but not limited to, custom software develop-

ment, research, and training, will be needed to support these efforts.

Automon owns the rights to the system code contained within the Caseload

Explorer system and is solely able to make the necessary system modifications

required to provide the data feed technology and solutions and the systems and databases are proprietary. Any customization of software must integrate with the current Caseload Explorer System.

Responses must include all one-time costs associated with service delivery in addition to any reoccurring costs annualized to maintain these services.

Interested vendors are required to submit their proposals no later than July 6, 2018 to the email address provided in this CR AD.
